Minutes of the Burial Ground Sub-Committee Meeting held on Tuesday 6th September 2022 at 2.00pm in Victory Hall, Stanway Community Centre

Present: Cllrs Bloomfield (elected as Chair), Chambers (elected as Deputy Chair), A Norton (from 2.25pm) & Spademan and the Clerk

- 1.Elected Cllr Bloomfield as Chair and Cllr Chambers as Deputy Chair for the following Municipal Year 2022/23
- 2.Attendance and Apologies for Absence No apologies received
- 3.Declaration of Interest None were declared
- **4.Public Participation-** No members of the public attended
- 5.Minutes of the Burial Ground Committee Meeting of 3rd May 2022 APPROVED minutes of meeting.
- 6.Clerk's Report/ Update NOTED. There have been no further reports of graffiti since May 2022.
- 7.Financial Report RECEIVED & NOTED and AGREED on budget request for 2023/24 with expenditure @ £ 2,200 and income at £ 4,000, both proposed from the CGC Working Group Budget Review Meeting
- 8.Maintenance Report Update The Maintenance Operative provided a verbal report to the Clerk confirming that the whole site being maintained well and the Tree Surgeon had been in at the beginning of August to cut back any high hedges facing the road. Photos had been emailed recently showing the burial ground. The Clerk will contact Bowmans to attend for the yearly meadow cut back and discuss when, what type, and who should re-seed the meadow for next year. No equipment was identified as being required. Tree bordering areas to fill in along Church Lane (by memorial/carpark) were identified – mature saplings were agreed upon. The Clerk will liaise with the Maintenance Operative regarding planting this Autumn and also place an order with CBC for free saplings for SPC to pot grow again for 2023 planting.
- 9.Maintenance of Existing Grave and Ashes Plots It was agreed that pre-paid plots would be allocated at time of death/first death (in the case of companion plots). The process (circulated by email) from ICCM regarding measuring depths and grave area to ensure compliance in accordance with up to date standards was accepted. Further training will be sought from the ICCM or similar regarding this and other processes
- 10. DECIDED to wait for the Committee site visit after the meadow had been cut to agree on further furniture
- 11. The Chair **UPDATED** that after a thorough site investigation with the grave digger, they managed to locate and confirm all grave Epitrace markers, with the exception of 4, which will be re-marked alongside the recent burials (x 4) and ash plot which have now settled. A site visit will be organised for the Committee and BG staff, after the meadow has been cut to mark out each grave by measurement, Epitrace and inserting a flush stake into the ground with the plot No. The Clerk will organise purchasing the necessary wooden pole and burnishing kit
