Minutes of Community Assets Committee Meeting held on Wednesday 21st April 2021 at 7.00pm.

In attendance – Cllrs. Jordan (Chair), Baines, Chambers, Norton, Spademan and the Deputy Clerk.

- 1. Chair's Welcome Cllr. Jordan welcomed everyone to the meeting and confirmed it would be recorded.
- 2. Apologies for Absence Apologies RECEIVED and APPROVED from Cllrs. Botha, Bloomfield and Williams.

- **7. Burial Ground Sub-Committee** Cllr. Chambers reported problems in obtaining three quotations for building a Memorial Wall. Two quotations considered and proposed to recommend acceptance of quotation from Cooke and Philips for approval at Full Council **NOTED**.
- 8. Play Areas and Open Spaces:
- **a) APPROVED** to begin investigation with play-equipment providers on the upgrade of the children's play areas at both SWG and LLS with a total budget of £80k for both projects combined.
- **b)** (Document of costs previously circulated). Confirmation that construction would begin on installation of adult gym equipment on SWG in mid-May **NOTED.**
- 9. Other Assets:
- **Swan Green Bus Shelter:** (Document previously circulated). Quotations for bus shelter base discussed and **APPROVED** to accept quote from Colne Contracts Ltd.
- Noticeboards: Further delay in delivery of noticeboards NOTED.
- **London Road Coronation Bus Shelter:** Shelter painted and inscription newly engraved, with costs given in Dept. Clerk's report **NOTED.**
- 10. Village Hall Complex:
- a) Tollgate carpark drains porosity testing complete and awaiting report, but likely recommendation will be that area unsuitable for soakaways and a new drainage system will need to be installed **NOTED.**
- **b) Tollgate Hall APPROVED** to proceed with a building survey condition report of Tollgate Hall at a cost of £1.5k.
