# Minutes of the Burial Ground Sub-Committee Meeting held on Tuesday 1<sup>st</sup> March 2022 at 2.00pm in Victory Hall, Stanway Community Centre

Present: Cllrs Bloomfield (Chair), A Norton, Spademan, the Clerk and the Maintenance Operative (from No. 7)

- 1.Attendance and Apologies for Absence Apologies were accepted from Cllr Chambers
- 2.Declaration of Interest None were declared
- **3.Public Participation-** No members of the public attended
- 4.Minutes of the Burial Ground Committee Meeting of 1st February 2022 APPROVED the minutes of that meeting

#### 5.Clerk's Report/ Update - NOTED

The Clerk has met with the Tree Surgeon and is currently looking at the tree cutting contract. After risk assessing, the Clerk has advised the maintenance operative that he cannot use a stepladder alone to cut high branches. All present councillors agreed to carry out an Epitrace audit at the Burial Ground in March and, if installing any replacement pens (by measuring), would do so with a shingle base. It was also agreed to leave graves for 3 months before inserting pens to allow the ground to settle further. It was agreed to add the provision of new granite name signage to the 2 entry walls @ £ 1250 to April's agenda with proposed etchings of a tree/woodland/meadow images.

**6.Financial Report** – Previously provided report (as below) was **NOTED**. The proposed income has been exceeded for 2021/22 and costs are under budget (excluding the memorial wall supply).

- **7.Maintenance Report NOTED** The Maintenance Operator will arrange for quotes to adapt the tap ASAP as he needs to start jet washing. A tree which fell over in the storms (18 & 21<sup>st</sup> Feb), near grave 23 has been cut back and removed, making the area safe again.
- **8.Maintenance of Existing Grave and Ashes Plots NOTED** The graves and ash plots are in good order. The Chair reiterated that no keepsakes were to be left by graves or attached to trees after one week of the interment. The Maintenance Operative will continue to store these items should visitors want to retrieve them.
- 9. To CONSIDER and AGREE Burial Ground Fees for the year 2022/23 After much consideration and discussion concerning the comparison report of natural burial ground fees within the area provided by the Clerk, AGREED to increase the Resident Single Depth Plot by £ 50 (ie., 16.5%) and apply this percentage increase to all grave plot fees. AGREED to increase Resident Interment of Ashes Single Depth Grave Plot to £ 120 (ie., 41%) and apply this percentage increase to all resident ash fees. AGREED to add categories for Non Resident Ash Plots and further double these Plot fees based on the 2022/23 Resident Ash Plot fees. All other fees remain unchanged. This follow a few years of no increase and still results in Comb Meadow being vastly cheaper than other compared local natural burial grounds. The new fees will take effect from 1st April 2022
- **10. Open Day** at Comb Meadow **DECIDED** to hold an open day for funeral parlours within a 10m radius of Comb Meadow on Wednesday 15<sup>th</sup> June (10-4pm). St Albright's Church Hall will be booked. Agreed that Comb Meadow should be featured at the Annual Parish Forum so residents are aware of what it can offer.

#### 11. To DECIDE on future publicity for Comb Meadow

The Clerk will present revised regulations and brochure concept at April 2022 meeting. All present were asked to provide photographs of the burial ground for publicity/brochure purposes. Once a new brochure is organised, leaflets can be added to the noticeboards and the website updated
