Cllr Hagon advised Colchester City Council are reviewing their Local Plan and are still working through the call for sites. Stanway community previously went through a Local Plan process so funding may not now be available.

With the inclusion of Items 2 & 3, the Council were clear in keeping the priority list focused on enhancing Stanway's infrastructure and transport facilities to enable the free flow of movement by encouraging and providing greener, alternative modes of transport to the car

- 16. RECEIVED an update from the Jansma Park Working Group. The transfer of land is ongoing but taking longer than expected due to an historical charge registered at the Land Registry. The Working Party will reconvene when the executors provide an update
