Minutes of the Corporate Governance Committee Meeting held on 15th February 2024 at 7pm in the Committee Room, Victory Hall

Present: Clirs Cotter (Chair), Baines, Hagon & Spademan, the Clerk & RFO

- 1. Cllr Cotter welcomed all present. Apologies were received and accepted from Cllr Seabrook due to a prior working commitment.
- 2. **Declarations of Interest –** None were declared
- 3. **Public Participation –** None present
- **APPROVED** the minutes of the Corporate Governance meeting held on 11th January 2024. The Chair signed the minutes as a true and accurate record
- Clerk's Report RECEIVED and NOTED
- 6. **RFO Report RFO Report** to **RECEIVE** an update regarding ongoing;
 - (i) Interim Management Accounts RECEIVED the latest interim management accounts and NOTED the latest bank reconciliation
 - (ii) Payment List RECEIVED the list of payments and APPROVED all expenditure. The committee were dissatisfied and wanted it recorded that 4 noncompliant transactions had been highlighted by the RFO ie., 3 payments were to new suppliers whose bank details were unverified and 1 x payment did not have the necessary purchase order, although the committee accepted the work had been authorised by this committee in December 2023.
 - (iii) To APPROVE any virements None presented
 - (iv) To **REVIEW** large capital projects, reserves and budget reports **No projects for review**
 - (v) **RECEIVED** an update on the Council's cash investments in relation to funds remaining in Barclays and Nationwide savings accounts. The Nationwide accounts have been closed and settlement received on the 30 day account, with the 90 day account settlement to follow 19th March 2024.

Cllr Baines, who now has the necessary authority to liaise directly with Barclays Bank, has been doing so to conclude closure of the accounts.

AGREED to lodge a complaint with the Ombudsman and if settlement is not received prior to this committee's March meeting, to make a decision regarding legal action against Barclays Bank.

7. To REVIEW the latest Local Highways Panel (LHP) report No new schemes in Stanway have been proposed. Cllr Baines suggested Full Council consider any scheme proposals in March so they can be proposed for 2024/5. They would also need Cllr Bentley's support
