Method of Application:

Spraying will be carried out using one of Weed Management's sprayers.

Method Statement and Risk Assessment:

These will be provided upon receipt of order or to the Weed Management spray operator at the time of application.

Terms and Conditions:

Our spraying procedures conform to the requirements of current legislation, including C.O.S.H.H, F.E.P.A and the Control of Pesticides Regulations.
